First addendum to the Subsidy Contract is signed on 26 March 2009 and 6 April 2009 respectively.

Both parties have agreed on the following:

1. The changes to the Subsidy Contract

Based on the approval of the Monitoring Committee as taken during its 8th meeting on 09 and 10 November 2011 and during its 12th meeting on 06 November 2013, the budget of IP Viborg is adjusted in order to adapt it to the approved additional staff positions.

Based on the approval of the Monitoring Committee as taken during its 9th meeting on 31 May 2012, the eligibility period is extended until 31st December 2015.

The duration of the operation will change accordingly:

01 July 2008 - 31 December 2015

Related to regional elections in Slovakia on 28 November 2009 and on 23 November 2013 respectively, the Statutory representative of the Managing Authority has changed accordingly:

Related to above mentioned, the Subsidy Contract is amended accordingly:

- Paragraph 2 „Purpose of Subsidy, Duration of Contract“, Article 2, the original sentence is replaced by the following sentence: The INTERACT Point shall be run by the beneficiary until **31 December 2015**;
- Paragraph 3 „Award of Subsidy“, Article 1, the end of the duration of the operation is replaced by **31 December 2015**;
