

## Fifth addendum to the Subsidy Contract for the Implementation of the INTERACT Point Turku

## Preamble

Based on the approval of the INTERACT II Monitoring Committee of budget reallocations as taken during its 12<sup>th</sup> meeting on 6 November 2013 (Dublin, Ireland), funding decommitted from other beneficiaries under priority axis 1 needs to be transferred to INTERACT Point Turku in the amount of EUR 196 000,00 in order to cover the financial needs of implementing the 2015 work plan until the end of 2015. The approved total maximum grant amount is thus increased from EUR 5 953 867,92 to EUR 6 149 867,92. Furthermore, the final reporting deadline is changed to 25 March 2016.

Furthermore it includes costs in the amount of EUR 1.713.219 for services and products to be developed by the INTERACT Point Turku in order to respond in a flexible way to the needs of its specific stakeholders assigned, in accordance with Chapter 4.1 of the Operational Programme as well as within the Multi Annual Work Programme." are deleted.
