Article 2 is replaced with the followings:

- 2. The project activities have to be carried out and finalised within the project period. Project expenditure with the exception of costs outlined in Article 2.3 has to be incurred and paid between the approval date of the project and the project end date as defined in Article 2.1.
- 3. Preparation costs can only be eligible if they were incurred on or after 1st January 2007 and **b**efore the date of approval of the Application Form by the Monitoring Committee, and paid before the end date of the first reporting period.

Costs incurred in the last reporting period and control costs related to the Final Progress Report have to be paid within 60 days from the project end date at the latest.
